*WMGU "NEW KIDS ON THE BLOCK 2024" TICKET TEXT TO WIN CONTEST OFFICIAL RULES *

A complete copy of these rules can be obtained by contacting radio station WMGU ("Station"), 1009 Drayton Road, Fayetteville, NC 28303, during available business hours Monday through Friday, on the Station website www.magic1069.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the WMGU "NEW KIDS ON THE BLOCK 2024" TICKET GIVE TEXT TO WIN CONTEST (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number per day of each Contest Round.
