LADIES KICKBACK PART 2: VALENTINE'S DAY EDITION 2025 ONLINE CONTEST OFFICIAL RULES

The Station will conduct the WMGU "LADIES KICKBACK PART 2: VALENTINE'S DAY EDITION 2025" ONLINE CONTEST (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.
